# New method to mitigate AMD from coal mines developed

GUWAHATI, June 28: Researchers from the Indian Institute of Technology (IIT) Guwahati have developed a new method to mitigate Acid Mine Drainage (AMD) in the coal mines of the Northeast. AMD refers to the acidic wastewater generated from coal mines or any polymetallic mines containing high amounts of sulfate, iron and various toxic heavy metals. "IIT Guwahati researchers have carried out a study of coal mines on the 'bioremediation' of AMD in constructed wetlands. This is the first study to demonstrate the bioremediation of AMD from the Northeastern Coalfields (NEC) using constructed wetlands," said a press release issued today by the institute. It added that the research provides an "efficient sustainable treatment approach to mitigate AMD pollution" while addressing the long-term operational sustainability issues encountered in constructed wetlands receiving AMD. "Furthermore, a biochemical mechanism has been developed to understand the functioning of different fundamental processes that co-occur in constructed wetlands. The key benefits of this research include optimisation of parameters with the use of simple organic carbon to provide an effective and sustainable solution for the mitigation of AMD pollution," said the press release. The research was carried out by Prof Saswati Chakraborty of the Department of Civil Engineering, IIT Guwahati, along with her research scholar, Shweta Singh, who studied the season-wise variation of AMD discharge in NEC. The research team conducted a laboratory-scale study in which preliminary findings demonstrated its potential for field-scale applications at the NEC for direct mine drainage. They developed an experimental methodology for the bioremediation of AMD and recommended optimising the chemical oxygen demand (COD) to sulfate ratio for the long-term treatment of AMD in constructed wetlands. "The results have successfully demonstrated the elimination of high acidity, sulfate and metals. Thus, it will help control water pollution and improve water quality through ecosystem restoration of the region," said the release. Highlighting the impact of the research, Prof Chakraborty said, "The preliminary findings from this research propose an effective strategy to manage the extremely acidic AMD from the NEC, which remains a challenging source of water pollution and environmental contamination due to mining activity in this region." The exploratory study has recommended the optimisation of the COD to sulfate ratio and provides an efficient and sustainable solution to mitigate AMD pollution in the Northeast region. "The implementation of this technology will ensure ecosystem restoration, thereby benefiting all the stakeholders at large... In this study, the simple and low cost easily available carbon source (lactate) is used for remediation of AMD wastewater," said the press release.

# Symposium on seismic disaster and mitigation held

GUWAHATI, June 28: A two-day-long symposium on 'Socio-technological aspects of seismic disaster and mitigation' concluded at the Indian Institute of Technology (IIT) Guwahati recently. It was organised to mark the 60 years of the Indian Society of Earthquake Technology (ISET). The event was jointly organised by the Centre for Disaster Management and Research (CDMR), the IIT Guwahati, the North Eastern Space Application Centre (NESAC), Assam State Disaster Management Authority (AS-

DMA), the Department of Earthquake Engineering of IIT Roorkee, and the ISET. Students and faculty from the Northeast and other parts of the country participated in the symposium and presented their research findings. The symposium included plenary talks, followed by invited talks in the domain of seismic disaster and mitigation by experts from across the country. "There is a need to learn particularly about vibration isolation techniques which were used in ancient structures. Further, regional seismic hazard should be given due importance in the current scenario," IIT Guwahati Director Prof TG Sitharam said while addressing the inaugural session. There were panel discussions in which experts from ASDMA and NESAC, as well as various industries, participated. They discussed about ways to deal with seismic disaster and mitigation and also direction in policy making. Some of the key speakers who participated in the event were Prof Rajib Shaw from Keio University, Japan, Prof Deepankar Choudhury from IIT Bombay, Prof ML Sharma from IIT Roorkee, Prof Subhadeep Banerjee from IIT Madras, and Prof Murali Krishna from IIT Tirupati.

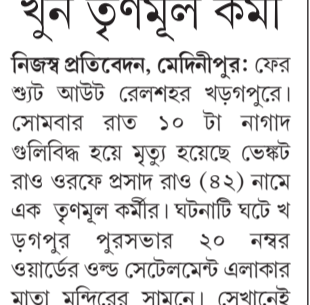

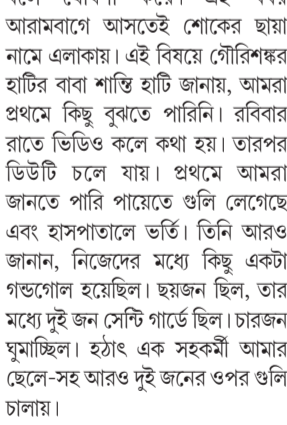
