Red alert continues, sporadic and intense rain affects normal life

Sea erosion threat looms large in Uchila, Battapady

Thunderstorms Predicted Across Coastal K'taka

Mangaluru: The coastal districts were marked by sporadic and often intense rainfall from Wednesday night till Thursday morning. The rain was less intense later in the day although a red alert had been issued.

Dakshina Kannada, Udupi and Uttara Kannada districts have been issued a red alert by the IMD for Friday too. The continuous rain from the past four days ensured that the rivers in the districts, that were bone dry just a week back, are swelling and pose a danger to residents on their banks in case rain continues its progress. The rain was heavy in Udupi district with three places getting record rainfall. Manipura in Udupi taluk, received 311mm rainfall, followed by Kantharava, Karkala taluk, at 306mm and Mudaranagadi getting 300mm rain.

The Dakshina Kannada and Udupi district administrations declared a holiday for anganwadis, schools and colleges on Friday.

The rain saw Bappanadu Durgaparameshwari Temple at Mulki and Sri Mahaganapathi Mahalingeshwara Temple at Padubidri getting inundated

with water reaching the inner precincts. The roofing of an educational institution at Talapady came crashing due to gusty winds on Wednesday night. Nobody was injured but many vehicles parked inside the school compound were damaged. Kottara Chowki in the city saw some inundation. Pumpwell area remained largely unaffected after the authorities cleared the drains after Monday's fiasco. A large portion of a hillock caved in at Veerakamba in Vittal taluk on Thursday, posing danger to motorists.

DK on Thursday in the last 24 hours, received an average 129mm rainfall as against the average of 35mm. The district administration stated that three persons died and three were injured in the last 24 hours. Mescom stated that 202 electricity poles, six transformers and 9km of supply line were damaged in the district.

Hoarding watch
Dakshina Kannada deputy commissioner Mullai Mukhan MP, who is also the chairman of the District Disaster Management Authority has directed the city corporation and urban local bodies to conduct a survey of authorised and unauthorised flex, hoardings and take steps to remove those which pose danger to public and property. The direction comes after many hoardings came crashing down in the city following gusty winds on Wednesday.

The IMD issued a thunderstorm with lightning warning accompanied by gusty winds with wind speed reaching 40-45kmph at isolated places over all the districts of coastal Karnataka till Monday. The department also predicted heavy rain in the region of 150mm to 204mm at isolated places over all the districts of coastal Karnataka.

Thunderstorms with lightning are also likely to occur at isolated places over all the coastal districts.

According to a rough sea alert issued by Indian National Centre for Ocean Information Services (INCOIS), high waves in the range of 3.5 to 4.5 meters were predicted along the coast of Karnataka from Mangaluru to Karwar. Fisher men have been advised not to venture into the sea till Friday.

Gadaiakalu entry banned
The forest department has banned entry of tourists to Gadaiakalu from July 7 in view of the dangerous conditions due to rain. The rock is located in the Kadremukh range of hills, near Belthangady. The fort is also referred locally as 'Jamalabad Fort' as the Gadaiakalu Fort was built by Tipu Sultan in 1794.

Mangaluru: Even as the threat of sea erosion looms large on people living along the coast at Uchila and Battapady, the Someswar Town Municipal Council (TMC) has been preparing to shift families to safer places.

Officials said, families will have to be shifted from the coast at Uchila, Battapady and surrounding areas if the inclement weather and high tide continues. They said a house collapsed late on Wednesday due to high tide and the family has been shifted to a safer location.

Ranjith Uchil, a social activist, told TOI that the situation is worsening due to the rain and rough seas. "The natural calamity may destroy many houses on the shore in Battapady and surrounding areas. The only road to the end point of Battapady was destroyed four years ago. However, nothing has been done to restore it till now and thereby several families are forced to walk. The authorities have been dumping boulders to prevent sea erosion, but the problem could not be solved yet," he said.

Sukesh GK, a social worker, said the compound wall of a property has collapsed

and if heavy rain continues, the house will also be destroyed. "Many families have shifted as the situation is worsening. There are possibilities of disasters if the rain continues to lash in the next few days," he added.

Someswar TMC chief officer Mathadri said the urban local body has already shifted a family as their house was damaged on Wednesday. "More families will have to be shifted if the situation worsens in the days to come. Depending on the intensity of rain and rough seas, we will make a decision. Our officials have already conducted a survey to identify houses which are prone to sea erosion damages. Many of the families live in their relatives' houses during the

One more dies

Mangaluru: One more death due to rain has occurred in DK, taking the toll to three. The deceased is Niranjan N Mudyava alias Nemiraj N Mudyava, 42, a resident of Mantradi village, Moodbidri. The Moodbidri tahsilidar has stated the next of kin of the victim will be given a relief of Rs 5 lakh. Mudyava had accidentally drowned in a pond, while he was checking the inflow of water to the fields, between Wednesday 9pm and Thursday 9am.

"he said, adding that the revenue department will compensate families for property losses.

Rain: Some schools, colleges go online

Mangaluru: With the Dakshina Kannada district administration declaring holidays for the third consecutive day due to heavy rains, a few schools and PU colleges have shifted their classes to online mode. Other schools said they are likely to adopt online mode, if the holidays continue.

The management of Ryan International School, Kular, Mangaluru, said they have shifted to online classes as of Thursday. A few schools and PU colleges have also shifted online. Other schools have decided to compensate for the lost classes by conducting

full-day classes on Saturdays. "The reason for shifting to online classes is that class tests are due in a week and the lessons have not been completed. We also have the technology ready to shift from offline to online. The technology was adopted during the pandemic, and it is coming in handy whenever schools remain closed," said a teacher of a private school, who is conducting online classes.

Sister Melissa, principal of Mount Carmel Central

undertake other academic learning," said Sameer Puranik, director of Sharada Group of Institutions.

"The moment we shift to online classes, a lot of students, who are from outside the DK, leave their hostels, thinking that holidays would extend for a few more days. Also, parents have to get ready with gadgets for the online class, which is an inconvenience to many," he added.

A similar view was expressed by Fr Robert D Souza, principal, Lourdes Central School, Bejai. "We are not feeling the need for online classes at the moment. Moreover, it is not convenient for parents, who have to arrange gadgets," he said.

Udupi: The incessant rains has led to the collapse of an unsuitably cut slope adjoining the government veterinary hospital building by the side of National Highway 169 at Sanoor on Thursday.

TOI had recently highlighted the issue of ongoing work on the widening of the national highway between Mangaluru and Sanoor; that poses threat to a government school and the veterinary hospital at Sanoor.

The school and veterinary hospital are located on elevated places by the side of the highway. As a result of the landslide, the veterinary hospital building is in danger.

Mangaluru: In the wake of a red alert issued by the IMD for Friday, Dakshina Kannada MP Nalin Kumar Kateel chaired a meeting on Thursday to ensure precautions in the district. He directed MCC, district administration, NHAI, forest department, public works and other department officials to take all necessary measures to prevent rain related damages. He told MCC commissioner Anand CL to ensure all blocks in storm water drains are cleared. He said necessary measures should be taken to allow rainwater to flow at places where the national highway works are being taken up. Mescom officials were asked to respond immediately when electric poles are damaged. NHAI engineers should keep their rapid response teams ready to clear blocks in case of landslides on the national highway on the Charamdi Ghat, Kateel said.

Residents also warn the inscientific cutting of hillocks near the school may also cause damage to its building.

The school SDMC and social activists had informed the authorities concerned including the National Highway Authority of India (NHAI) and the district administration about it. NHAI officials had visited the spot near the veterinary hospital on Tuesday.

The hillock was covered with plastic sheets to prevent water percolation. However, the wet soil collapsed, posing a threat to the veterinary hospital building.
