The Government of India recently reported that India's electronics imports have gone down and exports have gone up thanks to the Make in India initiative. Imports of completely boxed units of electronics such as smartphones slumped 40% during April 23-Jan24, as per commerce ministry data. Same data also revealed that imports of plastic parts, which include the back cover, GSM antenna and camera lens of smartphones, were down 33% by volume and 26.5% in terms of value. For April to Dec 23 period, India's electronics exports grew a record 22.24% to cross the \$20-billion mark, driven by booming smartphone exports by Apple and Samsung.

Two major growth areas for electronics industry include: Smart Products (powered by IoT and/or AI) and Automotive Electronics. High-ticket items such as camera modules, display assembly and battery packs were imported in higher quantities last fiscal, underlying the need for deepening local value addition to make exports more competitive, analysts said.

But, these sectors come with their own unique challenges. They require a combination of top-of-the-line technical talent, R&D and design houses with international experience, state of the art manufacturing capabilities, and a solid academia-industry partnership. It also means that Pune's professionals need to be exposed to the latest electronics components, development boards, embedded systems solutions, EDA tools, test & measurement equipment, rapid-prototyping equipment, bench-top manufacturing equipment, and last but not the least: automated SMT manufacturing equipment. Plus, it must have a great pool of independent design houses,

contract manufacturers (aka EMS players) and test & certification labs to enable them to outsource highly complex challenges
